## PWDCC Waiver /Indemnification/Release

By signing this application and agreement, I hereby acknowledge and understand that:

I am participating in a Water Trial for dogs, and that this activity involves an element of risk.

These trials are open only to registered pure-bred Portuguese Water Dogs.

The dog entered must be at least six months old on the day of the trial, in good health, proper fitness and condition for the trial that they are about to enter.

I agree to abide by the rules, regulations, policies and guidelines established for Water Trials as set forth by the Portuguese Water Dog Club of Canada in the current PWDCC Water Trial Manual.

I agree to hold the clubs their members, directors, governors, officers, agents, volunteer organization, and individual helpers, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this or any dog brought to the trial by me while in or upon the trial premises or grounds or near any entrance there-to.

I agree to hold these same parties harmless for the disappearance, theft, death, injury or other harm and from any claim for damage or injury to my/our dog(s) or to me and mine whether such loss, disappearance, theft or damage or injury may be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned or by the negligence of any other person, or any cause or causes.

I agree that these clubs have the right to refuse this or any entry for cause which they shall deem to be sufficient.

I hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense including legal fees by the reason of the liability imposed by law upon any of the aforementioned parties damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself or on account of damage to property arising out of or in consequence of my participation in this water trial, howsoever such injuries, death or damage to property may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other person.
