

# The Portuguese Water Dog Club of Canada

## Breeder List Form 2024



The Breeders' list is now open for registration, this is a voluntary program effective September 1, 2022.

Breeders can opt to participate on the Breeder List and must list all their litters on the PWDC website. Or list their litters but opt not to be on the Breeder List.

**To be eligible:** This list is provided as a service to the public and our Breeder Members. It is not an endorsement of any individual breeder, but each breeder listed has agreed to the following criteria.

### PWDC Breeders on this list must:

- Be a member for at least one year (as per litter listing)
- Post All litters on the Available Puppies webpage (where are health testing is provided)
- Sell all puppies with New Puppy Membership
- Register all puppies registered with the CKC
- All be PWDC members in good standing when a bitch is owned by two or more breeders. The exception to this rule is if the co-breeder is a resident of the United States or other international location.
- Only allow their stud dogs to be used on fully health tested bitches
- Follow the PWDC Code of Ethics and breeding practices.

**Non-compliance will result in immediate removal from the PWDC Breeder List and the PWDC Member Breeder Litters List with no refunds should the following occur:**

- Not reporting a litter.
- Not individually registering puppies in a litter that is registered.
- Not registering a litter
- 1<sup>st</sup> oops litter, must be reported (accidental breeding where testing on the breeding pair is not complete)
- 2<sup>nd</sup> oops litter, removed from the list for minimum of 6 months or the remainder of the year.
- 3<sup>rd</sup> oops litter, no longer eligible.

**There is no cost for this list at this time. The criteria for posting a litter remains the same.**
