Neither a judge nor any member of his/her immediate family or household, nor any dog that lives with a judge or any such family or household member, shall be eligible to compete at a trial where the judge is officiating or performing an observer or provisional judging assignment. "Competing" shall include acting as a substitute steward.	Neither a Judge nor applicant Judge performing an observer or provisional judging assignment may compete or act as a Substitute Steward at a trial where they are officiating, judge a dog that lives with them, or judge a dog handled by a member of their immediate family or household member. Family and household members may serve as Club Stewards at trials officiated by those Judges, however, they may not serve as Substitute Steward for teams judged by those Judges. At a trial with more than one Judge, neither a Judge nor applicant Judge performing an observer or provisional judging assignment is permitted to compete or steward under a different Judge, however their family and household members may compete and Substitute Steward under a different judge.

The Host Committee must investigate and keep a written record of its findings and complete the reporting requirements as described below.

7b	Aggression policy	64	Make the aggression policy and procedure more clear		A Judge shall excuse any dog that in their opinion menaces, threatens or exhibits any sign that it may not be safely approached in a normal manner by the Judge or Official Trial Stewards. Behavior may include growling, showing or snapping its teeth and rolling its eyes. The Judge will write on the Judging Sheet: Excused: Aggression. The Judge will also fill out the PWDCC Judge's Form for Dog Aggression, checking the boxes that are appropriate for the circumstances. This form must be completed on the day of the trial and given to the Chair of the Water Trial Host Committee who will include it in the formal written dog aggression report submitted to the PWDCC Water Trial Committee Chair.
					Excusal by the Water Trial Host Committee
7c	Aggression policy	64	Add excusal by the Host Committee		A Water Trial Host Committee shall excuse a dog that in the opinion of the Committee has acted inappropriately aggressively toward a dog or a human. The Host Committee will fill out the Host Committee Form for Dog Aggression, checking the boxes that are appropriate for the circumstances. This form must be included in the formal written dog aggression report submitted to the PWDCC Water Trial Committee Chair.
					NOTE: A dog excused by a Judge or a Water Trial Host Committee for aggression shall be excused from all remaining elements of that water trial event, including practice days and all remaining trials held in conjunction. Additionally, the dog may not participate in future water trials until notified by the PWDCC Water Trial Committee of approval to participate.
					Water Trial Host Committee Procedure
					If a dog is reported to the Water Trial Host Committee for attacking or menacing a person or another dog, a minimum of 3 members of the Water Trial Host Committee shall immediately investigate and solicit witness statements from all parties wishing to give statements. No opinion, conjecture or reference to any other event shall be allowed in witness statements.

					<p>The Water Trial Host Committee shall together decide if inappropriate aggression has occurred and whether or not the dog should be excused. Where decisions are not unanimous a vote count shall be recorded.</p> <p>If the Water Trial Host Committee determines that the dog is not to be excused, the Host Committee Form for Dog Aggression and all related documents must be included with the Trial Report submitted by the Trial Secretary, but no formal Host Committee report to the PWDCC Water Trial Committee is required.</p>
7d	Aggression policy	64	Include all requirements in the manual and remove from the forms anything that appears to be additional rules that are not included in the manual		<p>After excusal by a Judge or by a Water Trial Host Committee, the PWDCC Water Trial Committee Chair must be notified by phone no later than the end of that day. All dog aggression forms and the written Host Committee report must be received by the PWDCC Water Trial Chair within 72 hours. The Handler and/or owner will be given a copy of the aggression form(s) the day of the trial, or within 72 hours if they have left the trial site. Images of the form taken with a smart phone are sufficient.</p>
					<p>The report from the Host Committee must include:</p> <ol style="list-style-type: none"> 1. Dog's name and registration number 2. Dog owner's name and contact information 3. Completed Host Committee Form for Dog Aggression 4. Completed PWDCC Judge Form for Dog Aggression (if the judge provided one) 5. Witness statements (if applicable) 6. Statement from the Host Committee that states why the dog was excused. If the decision was not unanimous the vote count must be included
7e	Aggression policy	64	Add that disqualification is a decision that may be made by the PWDCA Board of Directors		<p>The PWDCC Water Trial Committee will review the report within 72 hours and then immediately share the report along with its own recommendations with the PWDCC Board of Directors. The PWDCC Board of Directors may impose additional restrictions and may disqualify a dog from future water trials after considering the Judge's, Host Committee's and PWDCC Water Trial Committee's recommendations. Once the PWDCC Board of Directors has made a decision, the owner will be notified of the dog's eligibility for future water trials.</p>
					<p>Copies of aggression forms and report must also be included with the Trial Report submitted by the Trial Secretary to the PWDCC Water Trial Committee.</p> <p>Aggression reporting forms are available online in the water work section of pwdcc.org and blank copies of aggression forms must be provided at the water trial site by the Trial Secretary.</p>
