## Guidelines for Completing the DOG on DOG ATTACK FORM

If, for any reason, the Judge is unable to complete the form before the end of the trial, the incident is to be reported in the Trial Secretary's report to the PWDCC Water Trial Committee within 72 hours. The Judge will then complete the form as soon as possible and forward it to PWDCC Water Trial Committee Chairperson.

- Upon completion, Judge should have the exhibitor sign this form, and, if possible, hand a copy it to the exhibitor. If the exhibitor has left the trial site, the Trial Secretary must ensure receipt within 72 hours.
- Three copies should be made: The Judge should retain a copy. The Trial Secretary will send a copy to the PWDCC Water Committee Chairperson. The Exhibitor will be provided a copy.
