- 6. The adopted dog may not be transferred to any other person for any reason, if the adopter is forced to relinquish custody of the dog at any time, said dog will be relinquished only to PWDCC Rescue.
- 7. If the adopted dog is lost or stolen, the adopter will notify PWDCC Rescue immediately so we can use our resources to help locate the dog as soon as possible.
- 8. I agree to inform PWDCC Rescue of any major illnesses or death and cause of death of this dog.
- 9. I agree to inform PWDCC Rescue of changes to my address and contact information. This information is strictly confidential and is used for Club purposes only. This information cannot be divulged by the Club or its individual members.
- 10. There will be no refund or reimbursement for any expenses incurred by the adopter for the adopted dog, even if it is returned to PWDCC Rescue. All registration papers or records must be returned with the dog.
- 11. I agree to donate a minimum of \$450.00 to the PWDCC Rescue fund on adoption of this dog. This is non refundable.

Release and Indemnification
